**As part of the Magnet application process, the following documentation is required of ALL applicants:**

- 1. Magnet Application**
- 2. Marietta City Schools Registration Form**
- 3. A copy of the student's most recent nationally normed standardized test scores (e.g., ITBS, CAT, STANFORD-9) for reading AND math totals must be 75% or higher**
- 4. A copy of the student's most recent report card or transcript from last school attended. Required GPA: 3.0 or higher.**
- 5. Parent Contract**
- 6. Birth Certificate (copy acceptable)**
- 7. Custody Documentation (if applicable)**
- 8. DHR Form 3300 Eyes, Ears, and Dental (Form available via MCS website)**
- 9. DHR Immunization Form 3231 or notarized waiver (Form available via health care provider)**
- 10. Copy of child's Social Security number (not mandatory)**
- 11. Proof of Residency (Please choose one):**
  - A. Lease, rental agreement or rent receipt consisting of written evidence that the agreement is valid and current AND a current utility bill (gas, electric, water, home telephone or cable TV). Records must include the name and street address of the parent/guardian.
  - B. A current residential property tax statement or deed, AND a current utility bill (gas, electric, water, home telephone or cable TV). Records must include the name and street address of the parent/guardian.
  - C. A third person affidavit of residency signed, completed and notarized (good for 30 days, if temporary) AND A) lease or rental agreement consisting of written evidence that the agreement is valid and current and a current utility bill (gas, electric, water, home telephone or cable TV). Records must include the name and address of the third person signee. OR B) current residential property tax statement or deed and current utility bill (gas, electric, water, home telephone or cable TV). Records must include the name and address of the third person signee.
